NOTICE IS HEREBY GIVEN in accordance with order of the Office of the Governor issued March 16, 2020, the City Council of the City of Plainview will conduct its **Work Session scheduled for 6:30 p.m. and Regular Meeting at 7:00 p.m. on Tuesday, February 23, 2021**, at the Plainview Convention Center, 2902 W. 4th Street, Plainview, Texas by video conference in order to advance the public health goal of limiting face-to-face meetings (also called “social distancing”) to slow the spread of the Coronavirus (COVID-19). There will be no public access to the location described above. Action may be taken on each agenda item.


